Comparison of Research and Education in Global Health in France and Germany

This workshop is the fourth in a series of workshops exploring the commitment and the approaches of Germany and France to Global Health. Thus, the Centre Virchow-Villermé for Public Health Paris-Berlin aims to promote cross-border expertise and networks.

Summarizing our four-part workshop the series started with a first workshop comparing the German and French post-2015 development agenda. A second workshop dealt with general questions about structures, priorities and perspectives towards Public Health policies in the two neighbouring countries. These two first workshops were integrated into the World Health Summit. The third workshop in May 2015 in Paris focused on communicable and non-communicable diseases. For all these workshops the Centre Virchow-Villermé for Public Health Paris-Berlin has been inviting representatives from ministries from France and Germany, experts from international (non-go-

vernmental) organizations, from civil society, from universities, as well as representatives of the academic offspring to explore the strategies and policies that exist in the two countries in relation to select Global Health issues and to gain information where common initiatives already exist.

To end this comprehensive overview in Global Health issues the last workshop covers the topic of Global Health education and research in both countries. Organization, ways of financial support, research programmes, networks and cooperation will be compared and analysed in order to understand both systems better and to foster future joint education and research programs.

The conference language is English.

The workshop will be moderated by Prof. Ilona Kickbusch, The Graduate Institute Geneva.
